## THE RELEASE OF THE EQUITABLE SHARE OF REVENUE TO COUNTY GOVERNMENTS PURSUANT TO COUNTY ALLOCATION OF REVENUE ACT, 2015

The Constitution under Article 201 (a) requires that "there shall be openness in public financial matters". Further, Section 46 (2) of the Public Finance Management Act, 2012 requires the Cabinet Secretary to the National Treasury to publish in the Kenya Gazette revenue collections and exchequer issues by the National Treasury.

In this Regard and pursuant to the County Allocation of Revenue Act, 2015, and in consultation with the Controller of Budget, the National Treasury has released funds for July, August, September, and part of October, 2015 tranches of Equitable Share of Revenue to County Governments. Disbursements for October and November, 2015 are in progress, taking into account the County Governments bank balances at the Central Bank of Kenya (CBK). The disbursements are based on the cash disbursement schedule approved by the Senate. In this respect, here-below is a status report of disbursements and balances held in various bank accounts of County Governments at the Central Bank of Kenya (CBK) as at 19<sup>th</sup> November 2015:-
